The Content Suppliers that upload adult contents to our site must review the following guideline.

Guideline for Prohibited Content

Category	Explanation	Prohibited Contents	Allowed Contents
Rape	Sexual interaction and consent	Any performer in the following state • Sleeping • Hypnotized • Use of chloroform • Completely bound • Use of drugs • Excessive consumption of alcohol All sexual activity with a performer who cannot express consent normally is prohibited. Acts of molesting are prohibited. Contents that depict sexual crimes as works of art are prohibited.	Incapacitation outside of sexual activity, or plot that influences a performers ability to consent • Fake to be possessed or hypnotized • Kidnap as part of plot • Deceived as part of plot • Presence of alcohol/drugs • False impression of the own status to mislead into sexual activity • Bartering sexual activity for work/service/money(No consequences) • Being partially restrained or gagged

Force	Violent act	Excessive violence used on performer • Forcefully controlling performer's movement • Forcefully stepping on performer • Excessive slapping • Suffocating act • Blood during sexual activity • Weapon use during sexual activity • Self-inflicted harm • Cannot escape • Murder before, after, or in between sexual activity • Sexual activity with excessive violence	Non-violent act done to consenting performer • Controlling body of performer • Blocking of mouth OR nose • Stuffing objects in mouth • Slapping anywhere on body • Non-violent sexual activity • Slapping that causes light redness Non excessive self harm • Self inflicted gagging • Nose hook to self • Sucking of finger/toe of performer • Eye stretching Blood or violence unrelated to sexual activity • Murdered as part of plot • Weapon used as part of plot

Resist	Action which shows performer stopping consent	Performer verbally or visually indicating that they do not consent • Showing regret • Showing fear • Excessive pain • Crying • Excessive screaming	Verbal or visual resistance unrelated to sexual activity or the coercion of sex • Fear and pain of someone other than performer • Fear and pain of performer that is part of a plot Sexual activity that usually includes pain • Anal • Tears due to oral • Insertion for both opening • Obey refusal
Scat	Contents with scat	Below material appears in the contents, real or fake • Feces • Urine • Menstrual blood • Gastric Fluid • Enema inserted object and coming back out • Vomit • Chewed up food • Smegma • Phlegm	Below is not considered scat • Bodily fluid from ejaculation • Saliva

Beastiality	Sexual interaction with a non-human	Any performer depicting a non-human and portraying non-human behaviour during sex • Tentacle • Monster • Dead-being • Animal • Zombie	Any performer depicting a non-human but portraying human behaviour • Performer in a mascot costume • Humanoid (Ogre, angel, vampire, alien, ghosts, etc.) • Animal body paint
Incest	Incest act between performers	Performers in the sexual activity are third degree relative Cannot use words related to grandparents, parents, siblings, to express the relationship of performers	In-law relations

Child Pornography	Performer under the age of 18	• Appearance of performer under 18 years of age • Expression including age, which implies that the performer is under 18 • Individual under 18 appears in a location that is not public (Changing room, public bath, breastfeeding room, etc) Any characters under the age 18 may not be shown, including live action, anime or cartoon.

Submission of Performance Consent Agreement

The Content Suppliers who upload adult contents must submit an agreement that complies to the following.

1. The performer of the adult contents has consented to the appearance within said content
2. The performer must be at an age where they can legally appear in an adult content, and has been verified using a government issued ID and a copy of that identification document has been retained
3. The adult content is permitted by the performer to be distributed on this site, websites including this site, or the whole internet
4. If the mentioned work is being sold as a downloadable content, the performer consent to the fact the content can be downloaded by viewers

5. If we deem it necessary, the Content Supplier must immediately(within 3 business days) submit document proof for the aforementioned 1~4, and have the documents registered on the system beforehand and can be reviewed by us at anytime

Contract and Submission of Identification Document

The Content Suppliers who upload adult contents must sign a contract with us and submit a government issued identification document to us.

We kindly ask you to share with us any content removal requests from public institutions or human rights organizations related to the works that are uploaded.
